NOW, THEREFORE, BE IT RESOLVED By the Board of County Commissioners that the County Attorney is hereby directed and instructed to institute in the Court having jurisdiction proceedings having as the end and purpose of same the condemning for public highway purposes a strip of land thirty three (33) feet in width and..... feet in length through and upon the lands and premises hereinafter described , that is to say:

Beginning at the corner of Sections Seven (7), Eight (8) Seventeen (17) and Eighteen (18), Twp. Nineteen (19) North, Range Eleven (11) East and running thence 16.5 feet West; thence 660 feet South; thence 16.5 feet East; thence 330 feet North; thence 16.5 East; thence 330 feet North; thence 16.5 feet West to the place of beginning.

The motion was seconded and unanimously adopted.
