WHEREAS, the Board of County Commissioners of Tulsa County, Oklahoma, is further of the opinion, and now finds and determines that in order to provide the separate schools of Tulsa County, Oklahoma, with like accommodations to those provided for the majority schools of Tulsa County, Oklahoma, and in order to make available for public building purposes sufficient funds to meet the needs of the separate schools of Tulsa County, Oklahoma, there should be levied a taz of $4\frac{1}{2}$ mills on the dollar on the assessed value of all taxable property located within Tulsa County, Oklahoma, for the fiscal year commencing on July 1, 1938, said increased levy to be made pursuant to and in accordance with the authority granted by Section 10, Article 10 of the Constitution of the State of Oklahoma, for the purpose of erecting public buildings in Tulsa County, Oklahoma, for the use and benefit of the separate schools of said Tulsa County, Oklahoma.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma, in regular meeting duly assembled, that an election is hereby called to be held on the 6th day of September, 1938, to vote on the proposition of whether or not an excess levy of $4\frac{1}{2}$ mills, in addition to such amounts as are, or may be authorized by law, shall be levied for the fiscal year commencing on July 1, 1938, and ending on June 30, 1939, against all taxable property located within Tulsa County, State of Oklahoma, in order to provide funds for the purpose of erecting public buildings for the use and benefit of the separate schools of Tulsa County, State of Oklahoma; and

BE IT FURTHER RESOLVED that the Chairman or the Acting-Chairman of the Board of County Commissioners of Tulsa County, State of Oklahoma, be and he hereby is authorized and directed to issue a call and proclamation for said election, in the manner and form provided by law and the constitution and statutes in such cases made and provided.

The County Clerk of Tulsa County, Okkahoma, is also authorized, directed and empowered to attest such election proclamation and to affix the seal of his office thereto.
