BY THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, OKLAHOMA.

whereas, The County Clerk of Tulsa County, State of Oklahoma, has this date made application to the Department of Highways for the amount of money in the State Highway Construction Fund (State 4 mill levy) now in the State Depository to the credit of Tulsa County or hereafter to be collected from such source in Tulsa County and remitted to the State Treasurer during the fiscal year ending June 30, 1922, such application setting out in detail the action of this Board relative to the expenditure of funds derived from the levy for appropriations in lieu of mill rate levy for work on the State roads, engineering and equipment.

Now, Therefore, Be it resolved, by the Board of County Commissioners of Tulsa County, Oklahoma, that in the event this application is granted by the Department of Highways and vouchers for the amount of money to the credit of Tulsa County in the State Depository derived from the State $\frac{1}{4}$ mill levy, or hereafter collected in Tulsa County and remitted to the State Treasurer during the fiscal year ending June 30th. 1922, derived from such fund, are remitted by the Commissioner of Highways to the Treasurer of this County (Presuming that the total amount remitted by the Commissioner of Highways will be equal to the amount collected in the levy for appropriations in lieu of mill rate levy for work on the State roads, engineering and equipment) it is the intention of the Board of County Commissioners of Tulsa County to use the money obtained from the State Highway Construction Fund and received from the Commissioner of Highways for the improvement of the following State roads in Tulsa County, to wit:
