The Board of County Commissioners met in regularly adjourned session, on Thursday January 20th. 1927, with all members present: W W Stuckey, Chairman, W L North and Ed W Hedgecock, Members. O G Weaver, County Clerk Ex Officio Secretary.

The letter of Mrs, P J Murray in behalf of the Frances Willard Home requesting permission for Oklahoma Natural Gas Corporation to cross Section Lines, between Sections 9 and 16, Township 19, Range 13 East. Request is hereby granted, permission given by order Board of County Commissioners. The request is herewith given in detail:

Board of County Commissioners,
Tulsa County,
Tulsa, Oklahoma.

Gentlemen:

We propose to lay a two inch gas pipe line from our Home located within the Northwest Quarter of the North East Quarter of Section 21, Township 19 North, Range 13 East, running West to the half Section line thence North through the center of Section 16, to connect to Oklahoma Natural Gas Corporation's line running along the North side of 21st. Street, Tulsa Oklahoma, which is the section line between Sections 9 and 16, Twp 19 N., Rge. 13 East.

In the construction of the line as above set forth we will cross the highway between Sections 9 and 16, Twp 19 N., Rge. 13 E., at a point about five feet East of the Half Section line extending from the Southwest corner of the Southeast Quarter of Section 9, across into the Northwest corner of the Northeast Quarter of Section 16. We will also be within the strip dedicated for Street and road purposes along the West side of the Southwest Quarter of the Southwest Quarter of the Southeast Quarter of said Section 16, being five feet East of the Half Section line through this tract of land known as Exposition Gardens Addition to Tulsa, and will extend just across the Section line between Sections 16 and 21, Twp 19, N., Rge. 13 East, running thence East along the North side of said NW $\frac{1}{4}$ of NE $\frac{1}{4}$ of said Section 21 to our Home.

This line will be our own private line to supply gas to the Frances E. Willard Home and it is very much desired that permission be granted us to construct maintain, operate and remove two inch gas pipe line along, under and across certain highways as above set forth.

In that we are very anxious to get this constructed at the earliest possible date, your action on this matter at your earliest convenience will be greatly appreciated.
