THEREUPON, Commissioner W.L. North offers the following Resolution and moves its adoption:

WHEREAS, Public Service Company of Oklahoma has requested this Board to grant permission to said Company to establish a pole line carrying electric wires for power purposes in this County, commencing at a point 17 feet North and 17 feet West of the Southeast Corner of Section 25, Township 20 North, Range 13 East, and extending North 17 feet West of East line of Sections 25, 24, 13, and 1, for a distance of approximately 5 miles to where the paved road turns in a Northeasterly direction, then parallel with, and 17 feet Northeast of center line of paved road to where said paved road turns North, then North 17 feet West of East Line of Section 36, Township 21 North, Range 13 East to a point 17 feet North and 17 feet West of the Southeast Corner of Section 25, Township 21 North, Range 13 East, then extend East 17 feet North of South line of Section 30, Township 21 North, Range 14 East, for a distance of approximately  $\frac{3}{4}$  mile to the Town of Owasso, Oklahoma, all in the County of Tulsa, State of Oklahoma, and

WHEREAS, it appears that said petition be granted:

NOW, THEREFORE, BE IT RESOLVED, That permission be and it is hereby given to the Public Service Company of Oklahoma, to construct, operate, and maintain a pole line on the public highway in Tulsa County, Oklahoma, at the location described as follows, to-wit:

Commencing at a point 17 feet North and 17 Feet West of the Southeast corner of Section 25, Township 20 North, Range 13 East and extending North 17 feet West of East line of Sections 25, 24, 13, 12 and 1, for a distance of approximately 5 miles to where the paved road turns in a Northeasterly direction, then parallel with and 17 feet Northeast of center line of paved road to where said paved road turns North then North 17 feet West of East line of Section 36, Township 21 North, Range 13 East to a point 17 feet North and 17 feet West of the Southeast corner of Section 25, Township 21 North, Range 13 East, then extend East 17 Feet North of South Line of Section 30, Township 21 North, Range 14 East, for a distance of approximately  $\frac{3}{4}$  mile to the Town of Owasso, Oklahoma, all in the County of Tulsa State of Oklahoma:

#### P E T I T I O N .

Comes now, Public Service Company of Oklahoma, a corporation, and shows to the Board of County Commissioners of Tulsa County, Oklahoma, that it furnishes electric light and power to the Citizens of Tulsa and vicinity, all in Tulsa County, Oklahoma, and said Public Service Company of Oklahoma desires to build, equip establish and maintain a pole line on the public highway on the section road commencing at a point 22 Feet North and 22 feet East of the Southwest corner of Section 17, Township 20 North, Range 13 East, and extend East 22 feet North of South Line of Section 17, Township, 20 North, Range 13 East, for a distance of 1 mile to a point 22 feet East and 22 feet North of the Southwest corner of Section 16, Township 20 North, Range 13 East, then extend North 22 feet East of West Line of said Section 16, for a distance of  $\frac{1}{2}$  mile, then East for a distance of approximately  $\frac{1}{4}$  mile, to present location of the City of Tulsa's water pump station, better known as the Mohawk Reservoir. All in Tulsa County, State of Oklahoma, in accordance with attached map, for the purpose of conducting electric current over the same for furnishing current to the Mohawk Pumping Plant of the City of Tulsa, and other prospective customers, and

WHEREAS, in constructing and operating such pole line it will be necessary to build and maintain the same with wires thereon on the public highway.

NOW, THEREFORE, Public Service Company of Oklahoma hereby requests the County Commissioners of Tulsa County, Oklahoma, to permit the location of such pole line on the public highway commencing at a point 22 feet North and 22 feet East of the Southwest Corner of Section 17 Township 20 North, Range 13 East, and extend 22 feet North of South line of Section 17 Township 20 North, Range 13 East, for a distance of 1 mile, to a point 22 feet East and 22 feet North of the Southwest corner of Section 16, Township 20 North, Range 13, East then
