Section 2. That an emergency exists for the preservation of the public peace, health and safety, by reason whereof this resolution shall take effect from and after its adoption and approval.

RESOLUTION

WHEREAS; in the opinion of the Board of County Commissioners of Tulsa County, Oklahoma, it is to the best interest of the tax payers of Tulsa County, Oklahoma, that all the cost of maintaining, patroling and repairing township roads and bridges of Tulsa County, Oklahoma, for the fiscal year ending June 30th, 1934, be paid from the County Highway Fund of said County, and

WHEREAS, the Attorney General of the State of Oklahoma, in an opinion rendered to the County Attorney of Tulsa County, Oklahoma, has ruled that a portion of the gasoline excise tax accruing to said County Highway Fund of Tulsa County, Oklahoma, may be expended for the aforesaid purposes, and

WHEREAS, the County Clerk of Tulsa County, Oklahoma, has heretofore issued warrants in payment of certain claims made by claimants for patroling, maintaining and repairing certain township roads and bridges; said warrants being issued against appropriations allowed for township purposes for the fiscal year ending June 30thm 1934, and

WHEREAS, the aforesaid referred to township appropriations were made principally from surpluses represented by delinquent taxes in process of collection as of June 30th, 1933, and

WHEREAS, it appears that the collection of said delinquent taxes may not be made in a reasonable period of time, to be applied against the aforesaid township warrants which have heretofore been issued.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma, as follows:

SECTION; That the County Clerk of Tulsa County, Oklahoma, be and he is hereby directed to cancel all outstanding 1933-34 township general fund warrants of Tulsa County, Oklahoma, and issue in substitution thereof in like amounts and to the payee or their assigns or the regular holders thereof warrants drawn on the County Highway Fund of Tulsa County, Oklahoma, for the fiscal year 1933-34.

SECTION 2, It is further resolved herein that the County Clerk of Tulsa County, Oklahoma, be and he is hereby directed to cancel upon the warrant register the aforesaid township warrants remaining unpaid as of this date, and he is further directed to notify the County Treasurer of Tulsa County, Oklahoma, of said cancellations.

SECTION 3, It is further resolved herein that the County Treasurer of Tulsa County, Oklahoma, credit the various funds of the various townships of Tulsa County, Oklahoma, with the amount of taxes which may subsequently accrue to said township funds, and that he hold said monies to the credit of the various township funds until such time as the Legislature of the State of Oklahoma makes a disposition of said township funds.

SECTION 4, That an emergency exists for the preservation of the public peace, health and safety by reason whereof this Resolution shall take effect from and after its adoption and approval.
