MONDAY, NOVEMBER 1, 1943

The Board of County Commissioners met in regular session on Monday, November 1, 1943, at the hour of 10:00 o'clock A. M., with all members present: J. B. Gray, Chairman, Curtis Greer and Robt. L. Kinkaid, members. Andy Stokes, County Clerk.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion made by Commissioner Greer, seconded by Commissioner Kinkaid, that the report of A. Garland Marrs, Sheriff of Tulsa County, for boarding county prisoners, for the month of October, 1943, be and the same is hereby approved and filed. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

J. B. Gray, Chairman Board of County Commissioners, deposited on October 28, 1943, with the County Treasurer \$7.10, same being insurance paid on damage by fire 9-25-43. Receipt No. 23183. Same was ordered filed.

Motion made by Commissioner Kinkaid, seconded by Commissioner Gray, that the claim of Mrs. Emily Jane Son, for damages in connection with Tulsa County Drainage District No. 12, in the amount of \$785.00, be and the same is hereby disallowed. Same being disallowed upon the advice of the viewers. Upon roll call, the following vote was taken. Commissioner Gray, Aye; Commissioner Greer, Pass; Commissioner Kinkaid, Aye. Motion was by the Chairman declared carried.
