

"Shall a water improvement district be established and organized pursuant to the provisions of Chapter 7, Title 82 OS 1941 (Paragraphs numbered 771 et. seq.), including the following territory:

All of that land situated in Sections Three (3), Four (4), Nine (9), and Ten (10), of Township Nineteen (19) North, Range Eleven (11) East, Tulsa County, Oklahoma, lying within and with boundaries as follows, to-wit: All of Charles Page Home Acres Subdivision No. Two, except Blocks 9, 17, and 18, all of Charles Page Home Acres Subdivision No. One, except Block Number Four (4), all of Hall's Garden Addition to Sand Springs, that part of the South Half ($S\frac{1}{2}$) of the South Half ($S\frac{1}{2}$) of the Southeast One Quarter ($SE\frac{1}{4}$) of Section Three (3) lying North of Charles Page Home Acres subdivision No. Two, the East One Half ($E\frac{1}{2}$) of the Southwest One Quarter ($SW\frac{1}{4}$) of the Southeast One Quarter ($SE\frac{1}{4}$) of Section Four (4) and that part of the South Half ($S\frac{1}{2}$) of the Northwest Quarter ($NW\frac{1}{4}$) of Section Ten (10) lying North of the North right-of-way line of the county highway, and all of the remaining portion of the North Half ($N\frac{1}{2}$) of North Half ($N\frac{1}{2}$) of the Southeast Quarter ($SE\frac{1}{4}$) of the Southeast Quarter ($SE\frac{1}{4}$) of Section Ten (10) lying North and East of the North right-of-way line of the county highway; and including Lot Fourteen (14), Block Eighteen (18), Chas. Page Home Acres No. 2, but excluding from the district a tract of land described as Beginning at a point on the East and West center line of Section Ten (10), Township Nineteen (19) North, Range Eleven (11) East, 341 feet East of the Northerly line of the County Highway; thence East 342.6 feet; thence south 510.7 feet; thence Northwesterly along the north right-of-way line of said county Highway 530.4 feet; thence Northeasterly to place of beginning.

Said election shall be conducted in accordance with the general election laws, and the regular election officials shall conduct the election at the usual or designated polling places for each regular precinct or part thereof within the proposed district, and the returns of said election shall be filed with the Board of County Commissioners.

The County Clerk is hereby directed to cause notice of such election to be given in full compliance with the requirements of the law and in particular to give two weeks notice by publication in the Sand Springs Leader, a newspaper printed in the county and of general circulation in the territory proposed to be included within the district, which notice may be substantially the following in form:

"NOTICE OF WATER IMPROVEMENT DISTRICT ELECTION"

Public notice is hereby given that an election will held on the 23rd day of October, 1945, from 6:00 o'clock a.m. until 7:00 p.m., at which election there will be submitted to the qualified electors in the territory hereinafter described to be by them voted upon, the following proposition:

All of that land situated in Sections Three (3), Four (4), Nine (9), and Ten (10), of Township Nineteen (19), North, Range Eleven (11) East, Tulsa County, Oklahoma, lying within and with boundaries as follows, to-wit: All of Charles Page Home Acres Subdivision No. Two, except Blocks 9, 17 and 18, all of Charles Page Home Acres Subdivision No. One, except Block Number Four (4), all of Hall's Garden Addition to Sand Springs, that part of the South Half ($S\frac{1}{2}$) of the South Half ($s\frac{1}{2}$) of the Southeast One Quarter ($SE\frac{1}{4}$) of Section Three (3) lying North of Charles Page Home Acres Subdivision No. Two, the East One Half ($E\frac{1}{2}$) of the Southwest One Quarter ($SW\frac{1}{4}$) of the Southeast One Quarter ($SE\frac{1}{4}$) of Section Four (4) and that part of the South Half ($S\frac{1}{2}$) of the Northwest Quarter ($NW\frac{1}{4}$) of Section Ten (10) lying North of the North right-of-way line of the county highway, and all of the remaining portion of the North half ($N\frac{1}{2}$) of the Southeast Quarter ($SE\frac{1}{4}$) of Section Ten (10) lying North and East of the North right-of-way of the county highway; and including Lot Fourteen (14), Block Eighteen (18), Chas. Page Home Acres No. 2, but excluding from the district a tract of land described as Beginning at a point on the East and West center line of Section Ten (10), Township Nineteen (19) North, Range Eleven (11) East, 341 feet East of the Northerly line of the County Highway; thence East 342.6 feet; thence South 510.7 feet; thence Northwesterly along the North right-of-way line of said County Highway 530.4 feet; thence Northeasterly to place of beginning.

Said election shall be held in the usual and hereinafter designated polliny places for each regular precinct or part thereof within the proposed district and such polling place shall be as follows:

Wekiwa Precinct No. 1 -- Mrs. Courtright's residence, one mile west of Sand Springs, Oklahoma.
