RESOLUTION ACCEPTING AND APPROVING CONTRACT,
SUPPLEMENTAL AGREEMENT AND BONDS OF F. M.
STOWELL, WITH TULSA COUNTY DRAINAGE DISTRICT
NO. 12, FOR CONSTRUCTION OF SEWER LINE

Now on this day, November 1st, 1943, and at a regular meeting of the Board of County Commissioners of Tulsa County, Oklahoma, acting as Commissioners of Tulsa County Drainage District No. 12, comes Conn Linn, Attorney for said Drainage District, and presents for execution and approval by this Commission, a certain contract, supplemental agreement, performance and statutory bonds, executed by F. M. Stowell, to Tulsa County Drainage District No. 12, on October 27th, 1943, for the construction of a sanitary sewer in South half of Section 12, Twp. 19 North, Range 11 East, in Tulsa County, Oklahoma, and said Contract, supplemental agreement and bonds having been considered and examined by said Board, and being fully advised therein, it is now therefore, by said Board, Resolved and Ordered, that said contract, and supplemental agreement be executed by Tulsa County Drainage District No. 12, by the Chairman of this Board, and attested by the County Clerk, which was then and there accordingly done in open session and it is further RESOLVED AND ORDERED by said Board, that said contract and supplemental agreement as executed, be and the same is hereby approved and ordered filed; that the Performance Bond and Statutory Bond executed by said contractor, F. M. Stowell, be and is hereby accepted and approved and ordered filed.
