RESOLUTION.

WHEREAS, it having been made to appear to this Board of County Commissioners that Midway addition to the City of Tulsa, Oklahoma, was laid out upon the homestead allottment of a creek Indian, and,

WHEREAS, prior to the decision of the Supreme Court of the United States in the year 1918 it was the understanding and belief that all such homesteads were non-taxable for a peropd pf twenty one years, and

WHEREAS, laboring under such understanding and belief the County Commissioners in thmes past made certain orders striking said Midway addition from the tax rolls of Tulsa County, Oklahoma, and

WHEREAS, after siad orders striking said addition from said rolls, the tax ferrit arbitratily re-assessed said addition without giving notice to the property owners thereof, and

WHEREAS, this Board did on the 28th day of March, 1922, make an order striking said assessments by said tax ferrit for certain years therein specified, but failed to make a further order directing the Coujty Treasurer to reassess said addition, or so much thereof upon which the taxes had not been paid for the years mentioned in said order, and WHEREAS, said midway Addition was properly taxable beginning with the year

NOW, THEREFORE, Be it resolved by the Board of County Commissioners of Tulsa County, Oklahoma, that all unpaid taxes in said Midway Addition for the years 1910 to 1914 both inclusive, be and the same are hereby stricken from said rolls, and the county treasurer of Said County is hereby directed and ordered to re assess all such lots.
