Chairman Miller presiding, the following business was transacted:

Commissioner Gray presented the following Resolution and moved its adoption:

RESOLUTION

WHEREAS, the Board of County Commissioners has heretofore presented to the Tulsa County Excise Board an application for supplemental appropriation in the County Highway Fund and it has become necessary to increase one item included in said request. Therefore, it be resolved that the Board of County Commissioners hereby request the Tulsa County Excise Board to increase Account #13, Road Oil & Emergency Maintenance, Bridges and Culverts from the sum of \$16,782.15 to the sum of \$20,742.21, being an increase of \$3,960.06, and that the Tulsa County Excise Board order same published as required by law. Motion for the adoption was seconded by Commissioner Bridges, and all members voting in the affirmative, motion was by the Chairman declared carried.

The County Engineer is instructed to obligate \$2,400.00 for Road Oil out of Acct. 13.

Nothing further to come before the Board, a recess is hereby taken until Monday, July 2nd, 1934, at the hour of 10:00 o'clock A.M.
