A G R E E M E N T

The Board of County Commissioners for the sum of One Dollar in hand paid, the receipt of which is hereby acknowledged and for other good and valuable considerations hereby stipulate and agree that they will vacate and deliver to the said J M Adkison that portion of the Southwest corner of the Southwest Quarter of the Southwest Quarter Section 28, Township 20 North, and Range 14, East, together with all buildings thereon May 14th. 1927. Said delivery shall be in full for all rentals or damages by the use and occupancy of said lands by said County of Tulsa.

It is further stipulated and agreed that the Superintendent of Public Schools in and for the County of Tulsa, Oklahoma, who is hereby made a party to this contract and agreement that he will vacate above described lands for school purposes and he hereby ratifies and confirms the within agreement and conditions and shall deliver such interest therein to the chattels, buildings, etc., as may remain on said lands at the time of vacating same, which such date will be May 14th. 1927.
