EXTENSION TO CONTRACT NUMBER 111A.

THIS AGREEMENT, Made this 11th. day of Augyst, 1924, by and between Tulsa County State of Oklahoma, by the Board of County Commissioners, acting for said County, parties of the first part, and BURKE-GIBBS, Contractors, of Tulsa, Oklahoma, parties of the second part,

WITNESSETH: That as provisioned, in the original contract between the parties hereto, for the paving and otherwise improving a portion of the County Highway, North of Skiatook, which contract is numbered and designated as Contract No. 111 A, said contract is hereby extended to cover the paving and otherwise improving of Mile 4, of Section A, said Highway, beginning at the South end of the Bird Creek Bridge, on said Highway, and extending South to the North end of the original contract as made and entered into on the 21st. day of April, 1924, and payment for such work as extended, to be made at the same unit item prices as contained and set out in the original proposal which involves approximately the following quantities and cost:

Said work to be done under the same specifications, and strictly in accord therewith, the same as though this extension of contract had been originally incorporated in the original contract; the second party to furnish satisfactory Surety Company Bond covering this extension, in the full amount of the estimated cost of such extended work.
