

removal of such lines and poles at will in whole or in part.

It is understood that the rights and privileges herein granted shall in no way be construed as an assumption of any responsibility on the part of the Board of County Commissioners of Tulsa County, or on the part of said County, but said Tidal Oil Company shall be responsible for any damage resulting from the construction of said telephone line, or which in any manner may be caused or occasioned through or by the use of same hereafter.

It is further understood that this Order, and the rights secured and granted hereby shall in no wise limit the right and authority of the County Commissioners, several Road Overseers and Trustees of the Public Highway in said County as the same is now provided by Law.

It is further ordered that said line shall be so placed and constructed as not to interfere with the use of any of the said public highways, or with the repairs thereof.
