Resolution:

before the Board of County Commissioners of Tulsa County, Oklahoma,

Whereas on the 10th day of Sept, 1910 it was ordered by the Board of County Commissioners of Tulsa County, Oklahoma, that Dry Drainage District Number One of Tulsa County, Oklahoma be authorized and empowered to issue bonds in the sum of Twenty Five Thousand Dollars (\$25,000), which bonds were ordered to be executed by this board for and on behalf of said Drainage District and it was further on subsequently ordered and passed by this board that the bid of the Columbia Bank & Trust Company for said bonds of said drainage district so as aforesaid ordered to be issued, be accepted and

Whereas it having become apparent to this board that the proper and legal sum in which the said bonds should have been issued is and was the sum of Twenty Five Thousand One Hundred Dollars (\$25,00) and

Whereas the said Columbia Bank & Trust Company has and did fail and omit to comply with the terms of purchase and their bid for the bonds of said Drainage District.

Now therefore be it resolved by this Board of County Commissioners of the County of Tulsa state of Oklahoma that the orders above recited, to wit the order authorizing the issue of said bonds in the sum of Twenty Five Thousand Dollars and the order accepting the bid of the said Columbia Bank & Trust Company for the bonds of said district, be revoked, rescinded, annulled and held for naught and that the records of said Drainage District and the minutes of this Board of County Commissioners pertaining to said bonds and the issue and sale thereof be completed and corrected in accordance hereith.

And be it further resolved, by this board that the issue of said bonds in the said sum of Twenty Five Thousand One Hundred Dollars (\$25,00) as ordered on May 9<sup>th</sup> 1910 and the sale thereof to F. S. Kunk for the sum of par value and accrued interest on said bonds, are hereby ratified and confirmed.
