Sealed with our respective seals and dated this 27th day of January, A. D. 1919.

WHEREAS? the above bounder "Principal" has entered into a contract with the said TULSA COUNTY by and thru its chairman of the Board of County Commissioners, bearing the date of the 27th day of January, 1919, for the improvement of sertain sections of highway in Tulsa County, State of Oklahoma, on the State Raod System thereof, being approximately fifteen (15) miles in length, for approximately the sum of Thirtyn Four Thousand Five Hundred (\$34,500.00) dollars, the said highways being situated as follows:

Sections H - D and miles one and two fo section A as shown on the officially designated State Road Maps filed with the Oklahoma Department of Highways and filed by the County Commissioners of Tulsa County Oklahoma.

WHEREAS, it was one of the conditions of the award of the County Commissioners, acting for and on behalf of Tulsa County, pursuant to which said contract was entered into, that these presents should be executed.

NOW THEREFORE, The condition of the above obligation is such that if the above bounden principal as Contractor shall in all respects comply with the perms of this obligation and conditions of this contract, and his, their or its obligations thereunder including the specifications therein referred to and made a part here of and such alteraltions as may be made in said specifications therein provided for, and shall well and truly, and in a manner satisfactory to the Board of County Commissioners of Tulsa County complete the work contracted for, and shall save harmless Tulsa County from any expense incurred throughtthe failure of the Contractor or his, their or its servants, or for any liability for payment of wages due or material furnished said contractor; and shall well and truly pay every person furnishing material ar performing labor in and about the construction of said roadways, all and every sum or sums of money due him, them or any of them, for all such labor and material for which the contractor is liable.
