The Board of County Commissioners met in regular session on Monday, January 2nd, 1940, at the hour of 10:00 o'clock A.M., with all members present: G. H. Shepard, Chairman; Ralsa F. Morley and Lincoln Sallee, members. Andy Stokes, County Clerk.

G. H. Shepard, Chairman presiding, the following business was transacted.

ORDER OF BOARD OF COUNTY COMMISSIONERS RELATING
TO SALE OF COUNTY PROPERTY ACQUIRED AT RESALE.

WHEREAS, the County Treasurer has presented to this Board the foregoing transcript of all his proceedings in said sale, with all papers and proofs relating to said sale, for the approval of this Board of County Commissioners, and

This Board of County Commissioners being convened in the office of the County Clerk of said County and State on the date hereinafter set forth.

WE HAVE CAREFULLY EXAMINED said transcript and proceedings, and find:

1. That the sale of Lot 2, Block 2, Liberty Add. to Tulsa; Lot 4, Block 4, Liberty Addition to Tulsa; Lots 16 and 17, Block 3, Lincoln Park Addition to Tulsa, to D. Smiley for a consideration of \$32.00 was properly advertised and fairly conducted and the amount of the sale is deemed a fair price.
