Motion was made by Mr.North, that the following Resolution be adopted: BE IT RESOLVED, That the Board of County Commissioners of Tulsa County, Oklahoma, now in regular session, all members being present, t at the Contract and Lease heretofore entered into on the 8th. day of February, 1927, by and between the Tulsa State Fair and Springer and Brown, a firm composed of H E Springer and F B Brown, in regard to race meetings on the Fair Grounds of Tulsa County, Oklahoma, be and the same is hereby ratified, confirmed and approved and signed in open session by each member of the Board and attested by the County Clerk. Motion to adopt was duly, seconded by Mr. Hedgecock, and declared adopted.

AGREEMENT --

THIS AGREEMENT, Made and entered into by and between the Midland Valley Railroad Company, hereinafter called the Railroad Company, party of the first part, and W L NORTH, W W STUCKEY and ED W HEDGECOCK, as the Board of County Commissioners of the County of Tulsa, Oklahoma, hereinafter called the Commissioners, parties of the second part:

WITNESSETH: That, Whereas, under contract entered into by and between the parties hereto under date of January 7, 1918, there was constructed an undergrade crossing across the right of way, terminals and yards and under the track of the Railroad Company in Garden City, Oklahoma, the expense of said structure being divided equally between the parties hereto, and

WHEREAS, it is necessary that said structure be renewed:

IT IS THEREFORE AGREED AS FOLLOWS:

- 1. The Railroad Company will renew said undergrade structure in accordance with plans shown on blue print heretoattached and made a part hereof at an estimated cost of \$5,500.00.
- 2. The Commissioners agree to pay to said Railroad Company one half of the actual cost of the renewal of said structure, such payment to be made immediately after July 1, 1927, or if the renewal is not completed by July 1, 1927, then payment to be made immediately upon receipt of bill after the renewal is completed.
- 3. It is agreed that the expense of future renewals of said undergrade crossing shall be equally divided between the parties hereto, and in the meantime the deck thereof will be maintained by and at the expense of the Railroad and the Highway underneath and across the Railroad Company will be maintained by and at the expense of the County.
- 4. Before this Contract is executed it shall be authorized by resolution of the Board of County Commissioners of Tulsa County, Oklahoma, adopted at a meeting of said Board, a copy of such reslution to be attached hereto.
