RESOLUTION

WHEREAS, Tulsa County owns a Ford Coupe, 1939 Model, Motor number 18-4861191, and a Ford Pickup, 1941 Model, Motor Number 18-6305537, and

WHEREAS, said Ford Coupe and Ford Pickup being in a state of bad repair and not generally serviceable for the uses and purposes of the Highway Department to which said Ford Coupe and Ford Pickup belongs, which was purchased from County Highway Funds, and

WHEREAS, the Highway Department is in need of a Pickup, and has found that a trade or exchange can be made with Adams Motor Company for a 1947 V-8 114" WB Pickup, Model 79 Y, Motor Number 799_199045, in exchange for the Ford Coupe and Ford Pickup, with a further consideration of payment by Tulsa County to Adams Motor Company the sum of One Thousand and Eighty-Eight Dollars & 50/100 (\$1088.50).
