MINUTES

MANAGEMENT CONFERENCE

Thursday, October 13, 1983

The Board of County Commissioners for Tulsa County, Oklahoma, met at the hour of 9:00 a.m. with the following members present: Terry Young, Chairman; Lewis Harris, Member; Melvin C. Rice, Member; Clayton Edwards, Chief Deputy; Mary O'Hara, Deputy County Clerk; Jim Myers; and Pam Infield.

Terry Young, Chairman, presiding, called the meeting to order at 9:07 a.m. and the following business was transacted:

Edwards reported that a meeting has been set with area hospital officials to discuss medical costs for county inmates.
