NOW, THEREFORE, BE IT RESOLVED, that permission be and it is hereby given to the Public Service Company of Oklahoma to construct, operate and maintain a pole line in Tulsa County, at the location described, and to carry on said pole line wires for conveying electric current of any voltage desired by said Company, said line to be constructed in accordance with Corporation Commission Order No 1946 and properly maintained in such manner as not to interfere with public travel or the use of said highways,
