WHEREAS, it is the opinion of the County Commissioners of Tulsa County, Oklahoma in meeting assembled, this 25th. day of August, 1924, that it is for the best interest of the County of Tulsa and for the comfort and convenience of the citizens thereof, that permanent bridges and (or) culverts should be built and constructed in Tulsa County and

WHEREAS, plans and specifications for said bridges and (or) culverts herein-after named and described.

NOW, THEREFORE, BE IT RESOLVED, That the Board of County Commissioners of Tulsa County, construct, according to said plans and specifications the following bridges (or) culverts, more particularly described as to location, materials, the approximate width of roadway, and depth of fill; the approximate length of span or arch, the approximate area of water shed to be drained by said bridges and (or) culverts, and the estimated costs of the same respectively, all as shown by the following schedule, to-wit:

P E T I T I O N.

Comes Now, Public Service Company of Oklahoma, a corporation, and hereby shows to the Board of County Commissioners of Tulsa County, Oklahoma, that it furnishes electric light and power to the Citizens of Tulsa and vicinity, all in Tulsa County, Oklahoma and said Public Service Company of Oklahoma desired to build, equip, establish and maintain a pole line on the public highway known as Federal Drive, commencing at a point where the present pole line terminates just East of the Rosehill Cemetery, and extend Eastward along said highway for a distance of approximately three and one half miles (3½) to a point approximately one half mile (½) East of the Western boundary of Section #6, Township 19 North, Range 14 East, said pole line to be erected on the North side of the said highway in a position to be determined by the County Engineer of Tulsa County, all in Tulsa County, State of Oklahoma, in accordance with attached map for the purpose of conducting electric current over same for furnishing such current to proposed customers along said highway, and whereas in constructing and operating such pole line it will be necessary to build and maintain the same with wires thereon on the public highway.

NOW, THEREFORE, Public Service Company of Oklahoma hereby requests the County Commissioners of Tulsa County, Oklahoma, to permit the location of such pole line on the public highway commencing at a point where the present pole line terminates just East of the Rosehill Cemetery, and extend Eastward along said highway for a distance of approximately three and one half (3½) miles, to a point approximately one half (½) mile East of the Western Boundary of Section #6, Township 19 North, Range 14 East, said pole line to be erected on the North side of the said Highway in a position to be
