MONDAY NOVEMBER 8TH, 1943

Pursuant to recess heretofore taken the Board of County Commissioners re-convened at the hour of 2 P. M. o'clock, with all members present: J. B. Gray, Chairman; Curtis Greer and Robt. L. Kinkaid, members. Andy Stokes, County Clerk.

J. B. Gray, Chairman presiding, the following business was transacted.

Mr. Hal Rambo appeared before the Board in behalf of Bertha Ewell and furnished sufficient evidence of good cause for her not having appeared before the Tulsa County Board of Equalization in regard to her affidavits of erroneous assessments on Lots 1-2-3 10-11-12 Block 13 Stonebreaker Heights to the City of Tulsa. Affidavits being for taxes covering the year 1943 in the respective amounts of \$73.29; \$5.96; \$2.99 and \$2.99. Motion made by Commissioner Kinkaid, seconded by Commissioner Gray, that sufficient evidence has been shown and that this board accepts evidence as presented. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.
