

R E S O L U T I O N .

WHEREAS, Senate Bill No 44 of the Extraordinary Session of the 9th. Oklahoma Legislature, 1924, among other things provides for the designation of County Highways. And,

WHEREAS, it is deemed to be to the best interests of Tulsa County that a County Highway be designated, "beginning at the corporate limits of Tulsa, with Lewis Avenue, and extending North along Lewis Avenue to the corner of Sections 17-18, 19 and 20, Township 20 North, Range 13 East, subject to further extension.

NOW, THEREFORE, BE IT RESOLVED, That a County Highway be so designated, and that the County Engineer be directed to take the necessary steps to pave with concrete and otherwise improve, the said highway, from the corporate limits of Tulsa along Lewis Avenue to the A T & S F Ry.
