## RESOLUTION.

NOW THEREFORE BE IT RESOLVED, That a County Highway be so designated, and that the County Engineer be directed to take the necessary steps to pave with concrete and otherwise improve, the said highway, from the corporate limits of Tulsa along Lewis Avenue to the A T & S F Ry.
