MONDAY NOVEMBER 15, 1943

Pursuant to recess heretofore taken the Board of County Commissioners reconvened at the hour of 10:00 o'clock A. M., with all members present: J. B. Gray, Chairman, Curtis Greer and Robt. L. Kinkaid, members. Andy Stokes, County Clerk.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion by Commissioner Greer, seconded by Commissioner Gray, that authority be given Dr. Oliver Hodge, Tulsa County Superintendent of Schools, to dispose of ten sections of bookcases to the separate schools and to transfer the necessary funds accordingly. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

J. B. Gray, Chairman Board of County Commissioners, deposited on November 12, 1943, with the County Treasurer \$.55 cents, same being the balance due for insurance paid on damage by fire 9-25-43. Receipt No. 23216. Same was ordered filed.
