WHEREAS, it appears that disposition of the tax claims of various Counties against the funds in the hands of said Receivers will in the near future be made.

NOW, THEREFORE, BE IT RESOLVED, By the Board of County Commissioners of Tulsa County in regular meeting assembled that the County Attorney be and he is hereby authorized and directed to enter into negotiations with said Receivers and their Attorneys for and on behalf of Tulsa County and to make such stipulations and agreements as he may deem necessary or expedient, having as it sobject and purpose the enforcement allowance by the Court and the collection of such taxes, if any, by reason of said Receivership as Tulsa County may be entitled to receive.
