

Beginning at a point within the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 30-18 N 14 E., and extending Easterly and Southeasterly to a point within the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Sec. 28, 18 N., R 14 E., a part of which is to be laid within the East and West Section line road along and approximately 23 ft. South of the center thereof between the SE $\frac{1}{4}$ of Sec. 18 and the NE $\frac{1}{4}$ of Sec. 29, all in Township 18 North, Range 14 East, according to blue print attached hereto and made a part hereof, a four inch gas pipe line known as C-W (Mary Flippin#4) Robitaille, et al.

AND, it further appearing from the petition herein that said pipe line will be so constructed as not to interfere with any of the rights of the general public in the use of said highways; and will be constructed in accordance with all rules of the County Comrs. and the laws of the State of Oklahoma governing same.

IT IS HEREBY ORDERED AND ADJUDGED by the Board of County Commissioners of said County that permission be granted and the same is hereby granted to Oklahoma Natural Gas Corporation, its successors and assigns, to use as much of the highways as above designated.

WHEREAS, the Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance of a deed conveying to him for a consideration of Seventy Two (\$72.00) Dollars the following described lots:

Lots 1 to 12, Block 30, Original Town of Skiatook.

AND, WHEREAS, the sale of said lots by the County Treasurer was made pursuant to Section 9745 of the compiled Statutes of Oklahoma of 1921, and amendments thereto, whereby the County Treasurer is authorized to sell lands and lots purchased for the County by him at tax re-sale, and

WHEREAS, due notice has been given and published by the County Treas. in the Tulsa Daily Legal News, the official paper of the County of Tulsa, that said County Treas. would on this date apply to the Board of County Commissioners for an order approving said sale, and directing the issuance of deed therefor, and
