BE IT FURTHER RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, OKLAHOMA, that Elmer W. Adams, County Attorney of Tulsa County, Oklahoma, be, and he is hereby authorized to accept the sum of \$3,000.00, plus court costs, in settlement of the judgments in the sum of \$3,000.00 each, in Case No. 78,898 and in case No. 78,899, District Court of Tulsa County, Oklahoma, and upon receipt of said moneys to pay into the Court Clerk of the District Court the sum of \$2,250.00, and to retain for his own use and benefit the sum of \$750.00, or 25% of the moneys collected, as is provided for by law.

BE IT FURTHER RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, that Cleo Epps, upon the settlement of said judgments, as above outlined, be, and she is hereby subrogated or the rights of Tulsa County, Oklahoma, in and to such judgments to the extent of the moneys paid, namely \$3,000.00.
