Pursuant to adjournment, the Board of County Commissioners met in their office with the following members present: Ed W Hedgecock, Chairman, W L North and W J Dickey, Members. O G Weaver, County Clerk.

Reading of the minutes of the previous meeting was dispensed with, and there being no objections to the same they were ordered to stand approved.

Motion was made by Mr. North, seconded by Mr. Dickey, that the resignation of WM CURRY, be and the same is hereby accepted.

Motion was made by Mr. Dickey, seconded by Mr. North, that the County Engineer be and he is hereby instructed to make a survey of the Section line running along the River Bank from Fifty-First (51st) Street to Twenty-First (21st) Street to determine the expense of opening the Section Line Road. Unanimously carried.

Motion was made by Mr. North, seconded by Mr. Dickey, that the appeal of the residents in the Leonard and Bixby School Districts (Nos. 47 and 23, respectively) be sustained and the action of the former County Superintendent, A G Bowles, be and the same is hereby ordered over-ruled. Unanimously carried.

Upon motion of Mr. North, seconded by Mr. Dickey, Dr. J B GILBERT is hereby re-appointed County Physician. All voting in the affirmative, motion was unanimously carried.

Upon motion of Mr. North, Jno. W. Brown and R M Darrow were made members of the Highway Police Patrol. Motion seconded by Mr. Dickey.

Upon motion of Mr. Dickey, AL (Link) Bowline, and Tom Duckett are made members of the Highway Police Patrol. Motion seconded by Mr. North.

Motion made by Mr. Hedgecock, seconded by Mr. North, that Wallace Davis and W D Foor be and they are hereby made members of the Highway Police Patrol. Motion carried.

Motion was made by Mr. Dickey, that TOM DUCKETT be and he is hereby made Captain of the Highway Police Patrol. Motion was seconded by Mr. North. All voting in the affirmative, was declared carried.

Motion was made by Mr. Hedgecock, that Mr. H A Parker be retained as County Engineer. Motion was lost for want of a second.

Motion was made by Mr. North, that Dan W Patton be and he is hereby appointed County Engineer, and that Mr. Stoner McLelland be put in charge as Temporary Engineer until such time as a decision is received from Mr. Patton. Motion was duly seconded by Mr. Dickey, and the following vote cast: Hedgecock, No. North, Yes. Dickey, Yes. Majority voting in the affirmative, motion was declared carried.
