O R D E R

Now on this 6th day of April, 1942, comes on for hearing before the Board of County Commissioners in and for Tulsa County, Oklahoma, the petition of more than twelve freeholders residing in the vicinity of the road affected hereby wherein said petitioners ask that an order be made and entered herein vacating and setting aside that certain road and the dedication thereof covering a part of

The Westerly 25 feet of the East Half $(E_{\overline{a}})$ of the Southeast Quarter $(SE_{\overline{4}})$ of the Southwest Quarter $(SW_{\overline{4}})$ of Section Twenty (20), Township Nineteen (19) North, Range Thirteen (13) East, Tulsa County, Oklahoma.

Said road to be vacated being a strip of land 25 feet wide and approximately 1260 feet long lying North and South along the Westerly side of the said E_{2}^{\pm} of SE_{4}^{\pm} of Suid Section 20, the southern terminal thereof being the North line of Forty-First Street and the northern terminal thereof being the South line of Thirty-eighth street.

And the said Board of County Commissioners, being fully advised in the premises, finds: That the allegations of said Petition are true; that said petition is signed by more than twelve freeholders residing in the vicinity of said road and is in all respects sufficient; that L. H.
