Resolution was introduced by Commissioner Short, who moved its adoption, for an extension of time in which the Contractor's shall begin construction of Drainage Ditch in Park View Drainage District No. 2, Tulsa County, Oklahoma. Time of extension is sixty three (63) days from the date of the Contract; which is April 17, 1922. The said resolution follows:

WHEREAS, on April 17, 1922, Tulsa County, State of Oklahoma, through its Board of County Commissioners, and Dahlstrom Improvement Co., of Tulsa, Oklahoma, entered into a contract for the construction of a drainage ditch in Park View Drainage District No.2 said County, such construction to begin within thirty days from said date; and

Dahlstrom Improvement Co. was to purchase the bonds to be issued for the purpose of providing finds for paying the cost of the construction of said ditch, such contract to be effective only in the event said company was awarded said bonds, the price being par, accrued interest and a premium of \$500.00, the bonds to be approved by the Attorney of said Company; and

WHEREAS, the Attorney for said company advises that it will be impossible to complete the examination of the proceedings had relative to the issuance of said bonds before the expiration of said thrity days; Now, Therefore:

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, STATE OF OKLAHOMA:

Section 1. That the time in which the Dahlstrom Improvement Co. of Tulsa, Oklahoma, shall begin work on the construction of the drainage ditch in Park View Drainage District No. 2, Tulsa County, Oklahoma, shall be and is hereby extended to Sixty three days from the date of the contract for the construction of said ditch, the date of said contract being April 17, 1922.
