Coming on for a hearing is Zoning Application CZ-139, Citizens Security Bank, Applicant, tract located East of Highway 64 and 71st St. South. Harris stated \$50. publication fee paid and hearing would proceed. Bob Gardner, TMAPC, appeared and gave background of subject property and stated that the Planning Commission voted to deny CH zoning and approve CS, except the East 150' which is to remain AG. Harris asked if anyone present to speak in favor of application. Charles Norman, Attorney for Applicant, appeared and requested CG zoning on the West 450', AG on the East 150', and CS on the middle portion. The Dog Kennel on the property could not operate with CS zoning without Board of Adjustment approval. Harris asked if anyone present to speak against application. There were none. Harris stated he talked with Mr. Terry West, protestant, by telephone and he has no objections to TMAPC recommendation if the board follows it. Harris stated he would not vote for a different zoning change unless protestant had been notified of such.
