Roy Evans, Chairman presiding, the following official business was transacted.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried that the progressive Estimate on the Jenks Bridge, submitted by Geo. O. Straughan, County Engineer, to Standard Paving Company, in the amount of \$5,028.98, be and the same is hereby approved.

Upon the instruction of the Chairman, the following sealed bids for the repair of the shed roof at the County Hospital at the County Farm were opened: Bohlander's Quality Roofing Company's in the amount of \$465.00; Standard Roofing & Material Co., in the amount of \$355.50, and Empire Roofing & Insulation Co., in the amount of \$310.45. Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried, that the bid of Empire Roofing & Insulation Co., in the amount of \$310.45, be accepted as the lowest and best bid, and the contract be and is hereby awarded to Empire Roofing & Insulation Co.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried, that the Financial Report of the County Clerk for the month of October, 1947, be and the same is hereby accepted and filed.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried, that the Report of the Clerk of the Court of Common Pleas for the month of October, 1947, be and the same is hereby accepted and filed.

Motion made by Commissioner Evans, seconded by Commissioner Bailey, that a recess be taken until the hour of 2:00 O'clock P. M. Motion carried.
