

A Petition and Resolution on Street Improvement District No. 1, was presented to the Board by A. M. Covington, Attorney, setting out the necessity of street improvements in that District. Commissioner Hardesty moved, that in order to conform with the law set out in H.B. 428, the following Resolution be adopted and a hearing set for Monday, August 29, 1949 at 10:00 o'clock a. m., and that notice of hearing be published according to law. Motion was seconded by Commissioner Bailey, and unanimously carried.

RESOLUTION

A resolution declaring local benefits accruing to property served by a limited access facility and declaring the necessity of and providing for the improvement of grading, paving, guttering and draining certain portions of the following streets, being a part of Ranch Acres, an Addition to the City of Tulsa, Tulsa County, Oklahoma; Florence Avenue: Beginning at South property line of 33rd street to paving in place at the South side of 31st Street 'East $\frac{1}{2}$ or East 13' 7" to be included; Florence Place: Beginning at the North property line of 36th Street and proceeding in a Northerly direction along Florence Place to the West paving line of Gary Place; Gary Avenue: Beginning at the North Property Line of 36th Street to the South side of paving along 34th Street provided herein; Gary Place: Beginning at the North property line of 36th Street to the paving in place on 31st Street (South side); 34th Street: Beginning at the East side of paving along Florence Place provided herein, to the West side of the paving along Gary Place provided herein; 33rd Street: Beginning at the East side of paving along Florence Avenue provided herein, to the West side of the paving along Florence Place provided herein and thereafter beginning at the East side of the paving along Florence Place provided herein to the West side of the paving along Gary Place provided herein, and thereafter beginning at the East Side of the paving along Gary Place provided herein to the West side of the paving in place along Harvard Avenue, and determining the necessity and advisability for such improvements and for creating a street improvement district and appointing engineers to report and declaring emergency.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, OKLAHOMA:

Section 1. It has been made to appear and the same is hereby declared to be necessary and essential to improve the hereinafter described portion of the following named streets and avenues all of which are within Ranch Acres, an Addition to the City of Tulsa, Tulsa County, Oklahoma, according to the recorded plat and which are streets or highways especially designed to furnish access to Harvard Avenue and 31st Street, both arterial highways near the City of Tulsa:

Florence Avenue: Beginning at South property line of 33rd Street to paving in place at the South side of 31st Street (East $\frac{1}{2}$ or East 13' 7" only to be included).

Florence Place: Beginning at the North property line of 36th Street and proceeding in a Northerly direction along Florence Place to the West paving line of Gary Place.

Gary Avenue: Beginning at the North property line of 36th Street to the South side of paving along 34th Street provided herein.

Gary Place: Beginning at the North property line of 36th Street to the paving in place on 31st Street (South side).

34th Street: Beginning at the East side of paving along Florence Place provided herein to the West side of the paving along Gary Place provided herein.

33rd Street: Beginning at the East side of paving along Florence Avenue provided herein, to the West side of the paving along Florence Place provided herein and thereafter beginning at the East side of the paving along Florence Place provided herein, to the West side of the paving along Gary Place provided herein, and thereafter beginning at the East side of the paving along Gary Place provided herein to the West side of the paving in place along Harvard Avenue.
