etc., to perfect the title month the plands communich, said Tulsa Aircraft Assembly Plant and the appurtenences are situated. Now, therefore,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, OKLAHOMA, AS FOLLOWS:

Section 1. That the BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, OKIAHOMA, through its proper officers, be and are hereby authorized and directed to execute a apecial quitclaim deed to the UNITED STATES OF AMERICA, copy of said quitclaim deed is attached hereto and made a part hereof, to the following-described roads, easements and county highways in Tulsa County, Oklahoma:

- (1) Fifty (50) feet off the West side of the West (W/2) half of the Southwest (SW/4) Quarter of Section Twenty-five (25), Township Twenty (20) North, Range Thirteen (13) East of the Indian Meridian, including the road that is now there.
- (2) Beginning at a point 25 feet West and 16.5 feet North of the Southeast corner of Section Twenty-four (24), Township Twenty (20) North, Range Thirteen (13) East of the Indian Meridian; thence North and parallel to the East line of said Section Twenty-four (24), a distance of 1,303.5 feet; thence East a distance of 8.5 feet; thence South, a distance of 1,303.5 feet; thence West, a distance of 8.5 feet to the place of beginning, and containing 0.25 acre, more or less.
- (3) Beginning at a point 45 feet West of the Southeast corner of the Northeast (NE/4) Quarter of Section Twenty-five (25), Township Twenty (20) North, Range Thirteen (13) East of the Indian Meridian, running thence North and parallel to the East line of said section, a distance of 1,320 feet to the North line of the Southeast (SE/4) Quarter of the Northeast (NE/4) Quarter of said section; thence East, a distance of 20 feet; thence North, a distance of 1,303.5 feet to a point 16.5 feet South and 25 feet West of the Northeast corner of said section; thence East, a distance of 8.5 feet; thence South, a distance of 2,623.05 feet; thence West, a distance of 28.5 feet to the place of beginning, and containing 1.12 acres, more or less.
- (4) A strip of land along the North line of the Northeast (NE/4) Quarter of the Northwest (NW/4) Quarter of Section Twenty-five (25), Township Twenty (20) North, Range Thirteen (13) East of the Indian Meridian, and described as beginning at a point 25 feet South of the Northeast corner thereof, and running West, a distance of 1,320 feet; thence North 8.5 feet; thence East 1,320 feet; thence South 8.5 feet to the place of beginning, and containing 0.25 acre, more or less.
- (5) A strip of land along the South side of the Southeast (SE/4) Quarter of the Southeast (SE/4) Quarter of Section Twenty-four (24), Township Twenty (20) North, Range Thirteen (13) East of the Indian Meridian, described as beginning at a point 25 feet North and 25 feet West of the Southeast corner thereof and running thence West, a distance of 1,295 feet; thence South 8.5 feet; thence East 1,295 feet; thence North 8.5 feet to the place of beginning, and containing 0.25 acre, more or less.
- (6) That part of the Southwest (SW/4) Quarter of the Southeast (SE/4) Quarter of Section Twenty-four (24), Township Twenty (20) North, Range Thirteen (13) East of the Indian Meridian, described as being a strip of land 8.5 feet wide along the South side of said land and lying adjacent on the North side of the present public highway right-of-way, and containing 0.25 acre, more or less.
- (7) That part of the Northeast (NE/4) Quarter of the Northeast (NE/4) Quarter of Section Twenty-five (25), Township Twenty (20), North, Range Thirteen (13) East, of the Indian Meridian, described as beginning at a point which is 25 feet North of the Northwest corner thereof, running thence East, a distance of 1,120 feet to the point of a curve to the right, the center angle of which is 90° and the radius of which is 175 feet; thance around the arc of said curve, a distance of 267.8 feet to the end of said curve; thence North 183.5 feet; thence West 1,295 feet; thence South 8.5 feet to the place of beginning, and containing 0.44 acre, more or less.
- (8) That part of the Northwest (NW/4) Quarter of the Northeast (NE/4) Quarter of Section Twenty-five (25), Township Twenty (20) North, Range Thirteen (13) East of the Indian Meridian, described as beginning at a point 25 feet South of the Northwest corner thereof, running thence East, a distance of 1,320 feet; thence North 8.5 feet; thence West 1,320 feet; thence 8.5 to the place of beginning, and containing 0.25 acre, more or less.
- (9) That part of the Southeast (SE/4) Quarter of the Southeast (SE/4) Quarter of Section Twenty-four (24), Township Twenty (20) North, Range Thirteen (13) East of the Indian Meridian, described as beginning at the Southeast corner of Section Twenty-four (24), and running North, a distance of 179 feet; thence West, a distance of 25 feet; thence to the South and West around the arc of a curve with a radius of 154 feet and a center angle of 90° 12' to the end of said curve; thence South, a distance of 25 feet; thence East, a distance of 179 feet to the point of beginning.
