RESOLUTION

WHEREAS, a portion of Lot 9, Block 3, Suburban Additon, a Subdivision in the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ Section 33, Twp. 19 N. Range 12 E. Tulsa County, Oklahoma, is needed by the County in connection with acquisition of right-of-way for the 51st Street Project; and

WHEREAS, said property can be acquired by amicable settlement from the owner, G. E. Malone, for a consideration of \$600.00, which amount is deemed to be fair and reasonable.

NOW THEREFORE, BE IT RESOLVED that the County purchase a portion of Lot 9, Block 3, Suburban Addition, Tulsa County Oklahoma, more particularly described as follows:

Beginning at the Northwest corner of said Lot 9; thence East along the north line of said Lot to the Northeast corner of said Lot; thence South along the East line of said Lot a distance of 26.73 feet to a point; thence Southwesterly to a point on the West line of said Lot; thence North along the said West line a distance of 88.45 feet to the Northwest corner of said Lot 9, and point of beginning,

paying therefor the sum of \$600.00, upon claim executed by said owner.

RESOLUTION

WHEREAS, a portion of Lots 2 and 11, Block 2, Suburban Addition, a Sub-division in the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ Sec. 33, Twp. 19 N. Range 12 East, Tulsa County, Oklahoma, is needed by the County in connection with the acquisition of right-of-way for the 51st St 51st Street Project; and

WHEREAS, said property can be acquired by amicable settlement from the owners Billie Evelyn Brown, and Carl Brown, her husband, for a consideration of \$5,900.00, which amount is deemed fair and reasonable.

NOW THEREFORE, BE IT RESOLVED that the County purchase that part of Lots 2 and 11, in Block 2, Suburban Addition, Tulsa County, Oklahoma, being more particularly described as follows:

Beginning at the Southwest corner of Lot 11 of said Block 2; thence North along the West line of said Lot 11 a distance of 80.3 feet to a point; thence North-easterly to a point on the North line of said Lot 11, said point being 42.31 feet East of the Northwest corner of said Lot; thence continuing Northeasterly across Lot 2 of Block 2 to a point on the East line of said Lot 2, said point being 30.1 feet South of the Northeast corner of said Lot 2; thence South along the East line of said Lots 2 and 11 to the Southeast corner of Lot 11; thence West along the South line of said Lot 11 to the Southwest corner of said Lot 11 and point of beginning,

and the improvements thereon, paying therefor the sum of Five Thousand, Nine Hundred Dollars (\$5,900.00) upon claim executed by said owners.
