the sum of \$102,435.96, and of this amount, with the surplus included you have the sum of \$74,425.77, leaving a deficit on this basis of \$28,010.19, which will have to be raised by the cancellation of unused and un-needed balances of appropriations and transferring the same to other accounts, if this can be done, and, if this cannot be done, the expenditures for the months of May and June will have to be reduced in order to meet your revenue.
