RESOLUTION

WHEREAS, Oklahoma Natural Gas Company, a Delaware corporation of Tulsa, Oklahoma, has applied for permission to cross or parallel, with an eight inch gas pipe line a county highway at the location shown on the accompanying map and described as follows:

Eight-inch gas pipe line crossing County Highway between Section 15 and 16, Township 20 North, Range 13 East at a point 45 feet North of the South line of said sections.

AND, WHEREAS, applicant has agreed to keep said line and its appurtenances in good repair at all times, and to remove said line at its own expense when such removal is necessary for the maintenance, repair or widening of the highway, and to comply with all the rules of the Board of County Commissioners and the laws of the State of Oklahoma in the laying and maintenance of said pipe line, and it appears that the said application should be approved and permission granted as requested.

NOW, THEREFORE, be it resolved by the Board of County Commissioners of Tulsa County, Oklahoma that Oklahoma Natural Gas Company be, and it hereby is granted permission to lay and maintain an eight inch gas pipe line at the location above specified.

At a regular meeting of the Board of County Commissioners of Tulsa County, Oklahoma, held on the 17th day of September, 1951, two members being present, the above resolution was introduced, its adoption moved and seconded, the vote upon said resolution being as follows:




