#### O R D E R

NOW, On this 7th. day of March, 1927, there coming on for hearing before the County Commissioners of Tulsa County, Oklahoma, in regular meeting assembled, the application of C W TITUS for an order of the County Commissioners of Tulsa County, Oklahoma, vacating and annulling a certain Dedication of Street or Road, dated May 16, 1917, given by H B Hamilton and Julia M Hamilton and filed for record in Book 242 at Page 367 of the records in the office of the County Clerk of Tulsa County, Oklahoma, whereby there was dedicated for street and road purposes a strip of land sixty feet (60') wide along the extreme westerly end of the South Half of the South Half of the Southeast Quarter of the Southeast Quarter of Section 13, Township 19 North, Range 12, East, Tulsa County, Oklahoma.

And it appearing that this tract of land has never been used to any extent whatever for road or street purposes; that the same has never been opened as a road subsequent to said dedication, and it further appearing that the petitioner is the owner of the tract of ground above mentioned and also the owner of a tract of ground adjacent thereto on the North, and that the ownership of both tracts of ground has been in one person for more than six years past, that said street or road does not lie along any section or half section line, and that the public has no use for said road, and that the County of Tulsa has no occasion to open said tract of land for use the same as a public road.

IT IS, THEREFORE, HEREBY ORDERED AND DECREED by the County Commissioners of Tulsa County, Oklahoma, that the Dedication of Road or Street made on May 16, 1917, by H B Hamilton and Julia M Hamilton dedicating for street and road purposes the strip of land sixty feet (60') wide along the extreme westerly end of the South Half of the South Half of the Southeast Quarter of the Southeast Quarter of Section 13, Township 19 North Range 12 East, Tulsa County, Oklahoma, be and the same is hereby vacated, annulled, set aside and declared void, and title to said sixty foot (60') strip of ground shall revert to the owner of the South Half of the South Half of the Southeast Quarter of the Southeast quarter of Section 13, Township 19 North, Range 12 East, Tulsa County, Oklahoma.
