Motion carried, all members having voted in the affirmative.

Motion was made by F.M.Wooden, seconded by Ira Short, that the request of the Ozark Pipe Line Corporation be granted. This request is for the erection, maintenance and operation of telephone and telegraph lines across lands situated in the County of Tulsa, described as follows: Along the West side of the Public Highway between Sections 13 and 14 Township 22 North, Range 13 East. All members voting the affirmative, the motion was declared carried.

Motion was made by F.M.Wooden, seconded by Ira Short, that the Public Service Company of Oklahoma be granted the permission asked for with reference to stringing telephone wires across the Tulsa County Bridge over the Arkansas River. Their request is in words and figures as follows:-

Tulsa, Oklahoma. May 23, 1922.

TO THE HONORABLE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY TULSA, OKLAHOMA.

Gentlemen:-

We desire to connect by private and direct telephone connection the operating department of the Public Service Company of Oklahoma Plant at First and Cheyenne Streets, Tulsa, with the operating Department of the PLANT OF THE Oklahoma Power Company, West Tulsa, and to make this connection it will be necessary to cross the river and we would ask the consent of your body to grant the company the right to cross the County bridge between Tulsa and West Tulsa with two #10 weather proof copper wires and the Okla. Union Railway Company will grant the use on their suspension wires such space as will be necessary for the construction of the line.

The purpose and the necessity of such a line is to insure closer communication between the operating departments of the two power plants, giving the public the benefit of improved operating service, also duplicating present telephone communication.

Would you kindly give this request your consideration and advise if our request meets with your approval.
