In the matter of the application of the Oklahoma Natural Gas Corporation, for permission to lay certain pipe lines, the following order was made:

## ORDER

NOW, On this the 7th. day of March, 1927, the matter of the petition of Oklahoma Natural Gas Corporation for permission to lay a pipe line along, under and across certain highways in said County and State came up before the Board of County Commissioners of said County for hearing, and it appearing to the Board and each of the Commissioners thereof that it was just that the said Oklahoma Natural Gas Corporation be permitted to use as much of the highways as designated by plat filed by said corporation, and according to said description, which is as follows, to-wit:

Beginning at a point within the NE<sub>4</sub> of SE½ of
Section 36, Township 21, North, Range 13 East,
and running in an easterly direction to a point
near the center of the south line of the NE½ of
Section 31, Township 21, North, Range 14 East,
an approximate distance of one mile; thereby
crossing the North and South section line between
Section 36, Township 21 N., Rge. 13 East and Sec.
31 Twp., 21 N., Rge. 14 East, together with any
other public roads or highways that might be crossed
by a gas pipe line laid in accordance with blue print
map of survey attached to the Petition herein and made
a part thereof. This line known as "Line J-W (H.Gassoway #1)
Extension", a five inch gas pipe line.

And it further appearing from the Petition herein that said pipe line will be so constructed as not to interfere with any of the rights of the general public in the use of said highways; and will be constructed in accordance with all rules of the County Commissioners and the lawsof the State of Oklahoma governing same.

IT IS HEREBY ORDERED AND ADJUDGED by the Board of County Commissioners of said County that permission be granted, and the same is hereby granted to Oklahona Natural Gas Corporation, its successors and assigns, to use as much of the highways as above designated.
