Motion was made by W L North, seconded by J S Shaver, that Contract No.

113 A be and the same is hereby extended to cover the cost of grading of the Tulsa-Wagoner County Line Road, beginning where the Tulsa County Pavement Southeast of Broken Arrow intersects the County Line and extending South to the corners of Sections 13 and 24, Twp. 17, North, Range 14 East, also beginning on the County Line at the Corner of Sections 1 and 12, and extending two miles West to the corner of Sections 2-3, 10 and 11 Township 17 North, Range 14 East at the same prices per cubic yard as provisioned in Contract No. 113 A, with the exception that clearing and grubbing, as well as removal and resetting of fences, to be paid for at cost plus 15%. All members voting in the affirmative, motion was declared carried.

There being nothing further to come before the Board, same was adjourned to meet on Monday, October 6th. 1924.
