Mr. Beeson added that new government guidelines require specific times for response and the Berryhill Fire District can respond to the area faster than Sand Springs can. He also stated he felt Homeland Security would be adversely affected by the withdrawal. He further stated he believed the petition signers must be registered voters.

The Commissioners stated there is a need to determine who is responsible for certifying petitioners are valid property owners so the validity of the petitions may be determined. There was a similar withdrawal about 10 years ago which could provide information as to certification and if statutes were followed.

Chair closed the public hearing at 10:55 a.m. Moved by Dick, seconded by Collins to continue this hearing for two (2) weeks until the August 30, 2004 Board of County Commissioners meeting at 9:30 a.m. There were no others with questions or discussion. Upon roll call, Collins, yes; Dick, yes; Miller, yes. Motion carried. (Clerk's Misc. File No. 194415)

Request for re-zoning appeal of CZ-343 which was denied by TMAPC on 6/16/04, from Kenneth C. Ellison, Applicant/Werner Knigge, Owner, located at Southwest corner of E. 116<sup>th</sup> St. & N. Memorial. Dane Matthews, INCOG, explained the vote to deny this application by the TMAPC. Mr. Ellison stated the owner would like to use the property for commercial purposes and mentioned other commercial properties within approximately 2 miles of this property. The following neighboring property owners stated their reasons for wanting this rezoning from AG to IL or CG denied: Tom Baker, 3821 E. 106<sup>th</sup> St. N., Sperry, OK; Mike Henley, 12116 N. 113<sup>th</sup> E. Ave, Collinsville, OK; Max Rider, 8304 116<sup>th</sup> E. Owasso, OK; Ray Wille, 8429 E. 116<sup>th</sup>, Owasso, OK; Sue Piggott, 8500 E. 116<sup>th</sup> St. N., Owasso, OK; Sandra Farney, 9611 N. Yale, Sperry, OK; and Jan Thomas, 7623 E. 116<sup>th</sup> St. N., Collinsville, OK. They stated that commercial attempts have failed several times in the immediate vicinity and they would have little control as to what type of business might be located there. The Commission praised INCOG/TMAPC for their due diligence in this and other matters. Moved by Collins, seconded by Dick, to deny applicants request for re-zoning of this property. Upon roll call, Collins, yes; Dick, yes; Miller, yes. Motion carried. (Clerk's Misc. File No. 194416)
