and for Tulsa County, Oklahoma, acting as Commissioners of Tulsa County Drainage District No. 12, that the County Clerk of Tulsa County, Oklahoma, be and he is hereby authorized and directed to set apart on the appropriation ledger of funds for the Tulsa County Drainage District No. 12 of Tulsa County, Oklahoma, the sum of \$3500.00, as an incumbrance against the funds belonging to said Drainage District for the purpose of paying off and satisfying the terms and obligations of Tulsa County Drainage District No. 12, to Southwestern Bell Telephone Company of Oklahoma, as provided by the terms of the contract with said Drainage District and especially the escrow feature thereof, stated in the latter partof Sec. 4, on Page 3, which is now on file herein, in which it is referred to and made a part hereof.

Thereupon, upon motion by Commissioner Greer, seconded by Commissioner Kinkaid, and a roll call and vote being had thereon the same was declared by the Chairman to be unanimously adopted.
