

TUESDAY, DECEMBER 8TH.1931.

Pursuant to adjournment, the Board of County Commissioners met in their office on Tuesday,December 8th.1931 at 9 o'clock A M with all Members present. O G Weaver, County Clerk.

Chairman Hedgecock presiding, the following business was transacted.

The matter of the adoption of the following Resolution was the first to come on for consideration, with the result that upon motion of Mr.Bohnefeld, seconded by Mr.North, the resolution was unanimously adopted:

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Tulsa County, in regular session assembled, deem it for the best interests that th three Commissioners Districts be more equally divided as to population, and

WHEREAS, the three Commissioners Districts as now constituted have existed as such for more than three years prior hereto.

NOW, THEREFORE, BE IT RESOLVED, that Commissioners District No.1, of Tulsa County be, and the same is hereby defined and shall comprise the following territory, to-wit:

Beginning at the Northwest junction point of Tulsa County with Osage County, thence South along the boundary line of said Counties to Edison Street, City of Tulsa, thence East on Edison Street to Cheyenne Street, City of Tulsa, thence North to Fairview Street, City of Tulsa, thence East to Main Street, City of Tulsa, thence South on Main Street to Sixth Street, City of Tulsa, thence East on Sixth Street to Lewis Avenue, City of Tulsa, thence North on Lewis Avenue to Archer Street, City of Tulsa, thence East to the Tulsa County Line

and comprising all of that territory in Tulsa County East and North of the lines above mentioned, same being redistricted as to population according to the largest vote cast in either of the two last general elections held in Tulsa County as follows, to-wit:
