and directed to prepare a notice of such contemplated improvement and advertise for sealed bids for the drilling of said well and improvement as provided for by law.

IN RE application of Oklahoma Eastern Oil Company, a corporation of Tulsa, Oklahoma, to construct pipe lines along and under public highways of Tulsa County, State of Oklahoma, to-wit:

Beginning at a point 934 feet North of the Southeast Corner of Section 23, Township 20 North, Range 12 East, and crossing the North and South highway between above mentioned Sections 23 and 24, thence running South along the East side of above mentioned highway to the Southwest corner of said Section 24, thence East along the North side of paved highway along South side of said Section 24, Township 20 North, Range 12 East, a distance of 42 feet, thence South under said paved highway to gasoline filling station.

NOW, On this 6th. day of October, A D 1924 at a regular meeting of the Board of County Commissioners of Tulsa County Oklahoma, held in compliance with and according to law, the application of Oklahoma Eastern Oil Company, a Corporation, of Tulsa, Oklahoma for the right to put down, construct and operate its one and one half gasoline pipe line, along and under the above specified public highways of Tulsa County, Oklahoma, which application is in writing and set a forth that it is necessary for the purpose of further advancing the business of said Company in the producing, marketing, transporting and conveying of gasoline as in said petition stated, to lay, construct, operate and maintain said pipe line along and under the specified public highways of Tulsa County, Oklahoma, comes on to be cosidered and asid Board after hearing said application and c considering same and being fully advised in the premises finds that said application should be granted.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED, That Oklahoma Eastern Oil Company, of Tulsa, Oklahoma, be and the same is hereby authorized and empowered to lay put down, construct, maintain and operate this its said gasoline line for the conveyance transmission and transportztion of gasoline along and under the said specified public highways of Tulsa County, Oklahoma.

IT IS FURTHER ORDERED, That said gasoline pipe line be buried so as not to interfere with the ingress and egress of adjacent farmers at the ordinary places of entrance to their lands, and at such other places along said highway where abutting land owners may desire to locate a place for entrance to their lands when so requested by the owners.

IT IS UNDERSTOOD, That in granting this order it shall in no wise be construeed as assuming any responsibility on the part of the Board of Commissioners of said County, or on the part of the said County, for any damages arising from the putting down, construction, and operation of said line, but the Oklahoma Eastern Oil Company shall be responsible for all damage accruing from the construction of said gasoline pipe line or which in any wise may be caused or occasioned thereby or by the use of the same.

IT IS FURTHER UNDERSTOOD AND AGREED, That this order and the rights hereunder and granted shall hereby in no wise abridge the right or authority of the County Commissioners, the Township Trustees and Road Overseers of the public highways in said County as the same is now provided by law.

IT IS FURTHER ORDERED, That said line shall be so used, made and constructed as not to interfere with the use of said public highways, nor the repair thereof, nor with the drainage of the highways, and in crossing streams and drains it shall be placed over or below the same x so as not to obstruct the flow of water therein, and when placed under the surface of highways, the surface of road bed thereof shall be restored to the same degree of safety for travel as the same was before said pipe line was put under the surface thereof.

## GAS SALES AGREEMENT.

THIS AGREEMENT, Made and entered into on this 30th. day of September, 1924, by and between the OKLAHOMA NATURAL GAS COMPANY, a corporation, party of the first part, and Tulsa County Poor Farm, party of the Second part.

WITNESSETH: That party of the second part agrees to purchase gas, and party f of the first part agrees to sell for domestic purposes in connection with one dwelling house on the following described premises, to-wit:

Section 34 - 19 - 13. Gas to be used for dwelling houses, boilers, and for general purposes

Tulsa County, Oklahoma, subject to the following terms and conditions:

l. Party of the first part to tap line, furnish and install meter and regulator, party of the second part furnishing suitable site for same; party of the second part to furnish service line, connections and fittings and install same subject to approval
