

Motion made by Commissioner Evans, seconded by Commissioner Couch, and unanimously carried, that the following Resolution be, and the same is hereby adopted:

RESOLUTION

WHEREAS, the Highway Department is in need of a Truck, and has found that, International Harvester Company, has a International Pickup Truck, Model KB-2, 125" WB, Serial No. 43968, Motor No. GRD214-146071, and that said International Pickup Truck, can be purchased by the Highway Department, from International Harvester Company, for a consideration of One Thousand One Hundred Seventy-Six Dollars and Eighty-five cents (\$1176.85).

NOW, THEREFORE BE IT RESOLVED, That the Chairman of the Board of County Commissioners be authorized to purchase said International Pickup Truck, and the County Highway Department be authorized to draw a claim to International Harvester Company, in the sum of One Thousand One Hundred Seventy-six Dollars and Eight-five cents, payable from Account Number 6B, designated as "Highway Equipment" of the County Highway Department Account of Cash Fund.

Motion made by Commissioner Couch, seconded by Commissioner Evans, and unanimously carried, that the position of Bridge Inspector, District 2, be abolished as of December 1, 1947, and that E. R. Horne, the former Bridge Inspector is to be taken off the County payroll as of December 1, 1947.

Motion made by Commissioner Couch, seconded by Commissioner Evans, and unanimously carried that Ed Strain be, and he is hereby appointed as Bridgeman for District No. 2, County Highway Department, as of December 1, 1947, at a salary of \$188.00 per month.

Motion made by Commissioner Couch, seconded by Commissioner Evans, and unanimously carried, that the salaries of Clarence McCutcheon, E. W. Reynolds and Ed Bruton, employees of the Highway Department, District No. 2, be increased \$10.00 each per month, making their pay \$198.00 each per month.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried that the Report of the District Court Division, District Court Clerk, for the month of October, 1947, be and the same is hereby accepted and filed.

Motion made by Commissioner Evans, seconded by Commissioner Couch, and unanimously carried, that Leonard Cook, Jr., be and he is hereby approved as a Deputy in the County Treasurer's Office, as of November 25, 1947, at a salary of \$150.00 per month.

Motion made by Commissioner Evans, seconded by Commissioner Couch, and unanimously carried, that the Bond, Order and Notice of Appeal, regarding the Application for correction of Erroneous Assessment, filed by Louise Warner, covering the South 75 Ft. of Lot 4, Block 166, OT City of Tulsa, be and the same are hereby accepted and filed, on the recommendation of the County Attorney.

Motion made by Commissioner Bailey, seconded by Commissioner Evans, and unanimously carried, that the Fire Run Contract of the Phoenix Insurance Company, between the County Commissioners and the City of Tulsa, on the County Farm property be approved, and the Chairman is hereby authorized to execute same.
