Pursuant to recess heretofore taken, the Board of County Commissioners re-convened at the hour of 11:00 o'clock A.M., with the following members present: John H. Miller, Chairman; and J. B. Gray, member. Andy Stokes, County Clerk. Harry L. Hopkins, member, absent.

Chairman Miller presiding, the following business was transacted.

Reading of the minutes of the previous meeting was dispensed with and there being no objection to the same they were ordered to stand approved.

Motion by Commissioner Miller, seconded by Commissioner Gray, that the affidavit of erroneous assessment filed by Louise H. Conway covering the So. 50' of Lot 2, Block 20, No. Tulsa Addition to the City of Tulsa, Tulsa County, Oklahoma, for the years 1930, 1931 and 1932, be and the same is hereby approved, and the County Clerk is hereby instructed to issue a certificate of error covering same. Motion carried.

Motion by Commissioner Miller, seconded by Commissioner Gray, that the application for correction of erroneous assessment filed by S. H. Thompson covering Lot 6, Block 2, Highland Addition; Lot 7, Block 2, Highland Addition; Lot 8, Block 2, Highland Addition and Lot 16, Block 4, Garden City, Tulsa County, Oklahoma, for the years 1930, 1931 and 1932, be and the same is hereby approved, and the County Clerk is hereby instructed to issue a certificate of error covering same. Motion carried.

The following Resolution was introduced by Commissioner Gray, who moved its adoption; said motion being seconded by Commissioner Miller. Chairman ordered the Resolution read.
