Section 17, Township 20, North, Range 13 East, which should be described as follows; to-wit:

"Beginning at the north line of Section 17, Twp. 20 North, Range 13, East at the quarter section corner, and described as a strip of land 50 feet in width, the center line of which follows the half section line to the center of said section, thence west along the center section line to the northwest corner of the NE¹/₂ of NE¹/₄ of SW¹/₄; thence south along the west line of the NE¹/₂ of NE¹/₄ of SW¹/₄ to the southwest corner of said NE¹/₄ of NE¹/₄ of SW¹/₄ to the juncture with a previously dedicated highway 50 feet in width which continues south to the southern boundary line of said Section 17".

Mr. Redman has been petitioning for this road for two or three years. He lives in Section 8, just north of Section 17, and the east and west section line between Sections 8 and 17 has never been opened and would be very expensive to open.

The probability is that a considerable part of the right of way would have to be condemned. The land marked Mary Ownes, is restricted Indian land and would have to be handled thru the Indian Department. E.B.Cline agrees to let us have right of way across his land. We will have no trouble with Mr. Murray. Koontz and Buckmaster may oppose the opening of this road.

For your approval, I hereby appoint Mrs. May Logan, as Stenographer in the office of County Attorney at a salary of \$125.00 per month, to take the place of Mrs. Nina C.Walker whose salary was \$135.00 per month. And I further recommend that the additional \$10.00 per month formerly paid to Mrs. Walker, be added to the monthly compensation of Joseph A.Gill, Jr., increasing his present salary to \$135.00 per month. All of the above to take effect May 1,1922.
